# TERMS AND CONDITIONS

Please read the following information carefully!

1. Admittance to the Good People Unity Gala will be determined solely at the discretion of the Wakanda OutReach Center (WORC). Criteria for acceptance includes, but is not limited to, compliance with all dates and time in this agreement, presentation and appeal of booth or display and date of application. A letter of acceptance will be sent via email to all those who are successful in the application process for the 2020 Unity Gala.
2. Location of table will be the responsibility of the Vendor Coordinator.
3. WORC reserves the right to refuse booths. We promote family-oriented goods. **ABSOLUTELY NO** food, beverage, knives, lighters, articles with profanity, body piercing services or drug paraphernalia, etc. can be sold at the Unity Gala. Please pay attention to wording on t-shirts and hats. If there are any questions to the suitability of an item, it will be up to the event coordinator to decide.
4. **SET-UP TIME**  
You may begin to set up your table on Saturday, February 29<sup>th</sup>, 2020 from 8:00 a.m. until 2:00 p.m. The gala begins at 5:00 p.m. SHARP. No table set-up will be permitted during gala hours.
5. **UNITY GALA HOURS OF OPERATION**  
Saturday, February 29<sup>th</sup>, 5:00 p.m. - 1:00 a.m.
6. **SERVICE AND DELIVERIES**  
All service and delivery people are to be in and out of the venue by 4:30 p.m.
7. **VENDORS TABLE**
  - 7.1. Sharing or subletting of table is strictly prohibited.
  - 7.2. Vendors are prohibited from providing their own music or sound system.
  - 7.3. **Absolutely no alcohol or drugs are permitted on a Vendor's table at any time.**
  - 7.4. Tables must be opened at 5:00pm and must remain open until 10:00 p.m.
  - 7.5. Selling outside your allocated space is prohibited.
8. **FULL PAYMENT** is required with the application. Wakanda OutReach Center (WORC) will accept certified cheques, money orders, or bank drafts made payable to Wakanda OutReach Center (WORC), cash or debit and Visa and MasterCard.
9. Table & Surrounding area cleanup are the responsibility of the Lessee.
10. **PETS: ABSOLUTELY** No pets are allowed in venue.
11. **INSURANCE**  
Wakanda OutReach Center (WORC), their employees, volunteers, agents, the property owners, management, etc., shall not be liable to the Vendor, his employees, agents, or customers for any personal injury or damage to property. Everything brought to the show premises by the Vendor, his employees and agents or customers, shall be entirely at the risk of the Vendor or others for any loss or damage in accordance with Canadian Insurance Laws.
